

## **Agreement for the payment of the Santander Universidades grant for the best UMCS doctorates**

represented by prof. dr hab. Radosław Dobrowolski, University Rector,

hereinafter referred to as the "University"

and

doctorate / UMCS, appearing later in the contract as a "PhD student", appearing jointly in

the remainder of the contract as "Parties".

### **§1**

The agreement specifies the method of payment of the grant by the University to the PhD student.

### **§2**

The funds for the payment of the grant are provided by the Santander Bank Polska S. A. Foundation, entered into the National Court Register under number 0000120807, by the District Court for Wrocław Fabryczna, VI Commercial Division, NIP 8971635900, REGON 93219814700000, Aleja Jana Pawła II 17, Warsaw 00-854, hereinafter referred to as the "Foundation"

### **§3**

The grant amount is ..... gross (in words:) and will be reduced by the amount of tax due.

### **§4**

1. The grant will be paid in the form of a one-time cash benefit to the account number..... within 14 working days from the date of signing the contract, run by Santander Bank Polska, of which the PhD student is the holder, however not later than 31 January 2022.
2. The University reserves the right to a delay where in the event of circumstances beyond the control of UMCS in Lublin the scholarship will be paid immediately after the end of the delay occurred.

### **§5**

The content of the Santander Universidades Grant for the best UMCS doctorates Regulations constitutes an integral part of this agreement.

### **§6**

1. The doctoral student declares that they have read the Regulations for awarding the Santander Grant Universidades for the best UMCS doctoral students and in relation to it circumstances listed in § 3 of the above Regulations do not apply.

2. The doctoral student also declares that at the time of signing this agreement, they have the doctoral student status of Maria Curie-Skłodowska University, in particular that by 30 November 2021, they were credited all required subjects and passed the prescribed exams planned for the summer exam session.

#### **§7**

1. In the event that a PhD student loses the status of a "doctoral student" as a result of the circumstances provided for in § 30 sec. 1-3 of the Study Regulations, they are obliged to return 50% of the value of the grant received.

2. The return is made within 14 days from the date on which one of the circumstances mentioned in paragraph 1 occur.

3. The refund is made to the bank account no. ....

4. The date of return shall be the day on which the funds are credited to the bank account, referred to in paragraph 3.

#### **§8**

1. The contract was drawn up in three identical copies, one for each of the Parties.

2. In matters not covered in the contract the provisions of the Civil Code apply.

3. Disputes that may arise from the implementation of the provisions of this contract will be settled by a common court competent for the location of the University.
