

Santander Summer Experience: London – Global Leadership and Creativity

Programme Timeline and Process, and Terms & Conditions

Overview

The Santander Summer Experience in London is a bespoke two-week opportunity for students from across the globe in July 2022. Hosted at King's College London and designed specifically for Santander scholars, this innovative programme looks at the themes of leadership and creativity through a global lens.

Research-enriched academic content taught by King's faculty will explore practice and concepts of creativity and leadership and how they continue to evolve in the light of global changes, creating a platform for students to develop and reflect on their own styles, global leadership abilities and to prepare for their professional futures.

Using London as a classroom, King's integrates experiential learning to enhance the student experience through guided weekly excursions as well as inviting guest speakers from industry to share knowledge and experience from a professional perspective. Scholars will embark on a personal adventure by joining this interactive, skills and knowledge building programme that is designed to stimulate them intellectually and empower them personally.

How to apply

Prior to applying for the programme, please take the time to read through the Terms and Conditions and ensure that you meet all the criteria listed below. Please also read this document to understand what you will need to commit to in terms of time.

If, after reading the Terms and Conditions, you would still like to apply, you must complete your application via the Santander Scholarship Platform. Please note: initial applications for phase 1 will be open from 09:00am 01/02/2022 until 11:00pm on 31/03/2022.

In order to apply for the programme, you must first register on the [Santander Scholarship Platform](#). Once your registration is complete, you will then also be able to apply for other opportunities hosted on the page (these will be subject to different Terms and Conditions).

Timeline and Key Dates

1. Application process (phase 1)

- Applicants wishing to apply for the programme must do so via the Santander Scholarship Platform. Applications for phase 1 will open at 09:00am on 01/02/2022 and will close at 11:00pm on 31/03/2022. Applications made outside of this time frame will not be considered.
- Applicants will confirm that they meet the eligibility criteria upon submitting their application via the Santander Scholarship Platform (see 'Eligibility criteria' section for further detail).
- Please see the 'Terms and Conditions for the Programme' section below for details on what information will need to be submitted as part of phase 1.
- Applicants will receive a confirmation email of their application from the Santander Scholarship Platform.

2. Confirmation of results (phase 1)

- Santander Universities will randomly select 150 participants (using an online random-selection platform) to progress to phase 2 of applications; this will be broken down into 25 students per country. - All applicants for phase 1 will be informed of the outcome on 06/04/2022 via an email from the Santander Scholarship Platform.
- The 150 applicants who progress to phase 2 will also receive an email from the Santander Scholarship Platform informing them that the next phase of applications is open.

3. Application process (phase 2)

- Applications for phase 2 will open on 06/04/2022 and will close at 11:00pm on 14/04/2022. Applications made outside of this time frame will not be considered.
- Please see the 'Terms and Conditions for the Programme' section below for details on what information will need to be submitted as part of phase 2.
- Applicants will receive a confirmation email of their application from the Santander Scholarship Platform.

4. Selecting the 60 successful students

- Santander Universities will share the data submitted by all applicants from phase 2 with King's College London, in order for the latter to identify the 60 successful students (10 per country).
- King's College London will review and evaluate all 150 applications submitted as part of phase 2. If you wish to find out more about this process, please contact santander.universities@santander.co.uk

5. Confirmation of results (phase 2)

- All 150 applicants from phase 2 will be informed of the outcome on 09/05/2022 via an email from the Santander Scholarship Platform.
- In parallel to this, the 60 successful students will also receive an email directly from Santander Universities confirming next steps.

6. Next steps for 60 successful students

- All 60 successful students must formally accept the opportunity via the link in the email (from the Santander Scholarship Platform) by 5pm on 16/05/2022.
- Once the 60 successful students have formally accepted the opportunity, they will receive an email directly from King's College London with a link to complete their enrolment on King's Apply, King's College London's platform.

Terms & Conditions

These Terms and Conditions apply to the Santander Summer Experience: London – Global Leadership and Creativity (to be collectively referred to as the "Programme"). By applying to the Programme, Applicants agree to be bound by the following Terms and Conditions:

1. The Grantor is Santander Universities UK (a division of Santander UK plc, 2 Triton Square, Regent's Place, London, NW1 3AN, United Kingdom).

Eligibility criteria

1. Applicants for phases 1 and 2 must meet the following criteria:
 - a. Applicants must currently be studying an undergraduate or postgraduate degree at a university in one of the following countries: the UK, Brazil, Mexico, Germany, Chile or Argentina
 - b. Applicants must be aged 18 years or older
2. Applicants shortlisted for phase 2 must be able to provide the following evidence:
 - a. Proof of English Language Proficiency to at least C1 level in the Common European Framework of Reference for Language (CEFR) or equivalent*
 - b. Proof of academic grades to be working towards at least a 2:1 or equivalent**
 - c. Personal statement outlining their reasons for applying
3. Applicants must confirm they meet the above criteria upon submitting their application.
4. Applicants must apply for the Programme via the Santander Scholarship Platform any time from 09:00am on 01/02/2022 until 11:00pm on 31/03/2022. The Grantor reserves the right to close the Programme early in exceptional circumstances.
5. Applications not submitted in accordance with these Terms and Conditions, or applications which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.

*English Language Requirements

All classes are taught and assessed in English, except ancient language modules. All applicants must have studied English to at least level C1 in the Common European Framework of Reference for languages (CEFR) or offer one of the below:

- Cambridge Advanced Certificate - grade B
- Cambridge Certificate of Proficiency in English - grade C
- CET-4 (China) – 550

- CET-6 (China) - 493
- Duolingo English Test, we require a minimum test score of 105
- GCSE/ IGCSE/ O-Level - grade C
- IELTS - 6.5 (or equivalent) with a minimum of 6.0 in each skill.
- International Baccalaureate- Standard Level 4
- iTEP - Level 5
- TOEFL Internet Based Test - 95 with minimum 20 in all skills (within the last 2 years)
- TOEFL Paper based test - 583 with minimum 53 in all skills (within the last two years)
- TEM, minimum score of 70
- TOEIC, minimum score of 685

If the applicant's first language is not English or the medium of instruction at their university is not English, they will need to provide evidence of their English proficiency from the list above.

****Academic Entry Requirements**

- Argentina: Distinguido (7.0) or above
- Germany: 'gut' (2.0) or above
- Mexico: 8 or above
- UK 2:1 grade bracket
- Brazil: 7 or above
- Chile: 5 (Bueno) or above

Terms and conditions for the Programme

1. Applications are open for all individuals who meet the criteria as listed in the 'Eligibility criteria' section above.
2. All individuals wishing to apply for the Programme must do so via the Santander Scholarship Platform.
3. Each Applicant can apply to the Programme only once. Successful participants will be enrolled onto the Santander Summer Experience: London, in collaboration with King's College London.
4. For phase 1 of applications, Applicants will be asked to provide their country of residence, university, full name including title, email address, date of birth, type and identification number of the country of residence or passport, gender, telephone number, nationality, education/qualifications including start and end date, area of expertise, professional experience and company sector, employment status and degree subject which will be shared with Santander UK plc and King's College London for the purpose of managing this Programme and shortlisting applicants for phase 2, as stated in these Terms and Conditions. For phase 2 of applications, Applicants will be asked to provide proof of English Language Proficiency to at least C1 level in the Common European Framework of Reference for Language (CEFR) or equivalent*, proof of academic grades to be working towards at least a 2:1 or equivalent **, and a personal statement outlining their reasons for applying to the Programme which will also be shared with Santander UK plc and King's College London for the purpose of managing this Programme and selecting the 60 successful students. Applicants will be advised when some information requested is optional and will be asked to provide consent to sharing their personal information with partner universities and partner businesses and for the processing of certain personal information. Information on how Santander Universities and partner businesses and partner universities process personal information can be found below.
5. It is the Applicants responsibility to ensure they read and understand the eligibility criteria and submit their application appropriately, on time and following the application instructions / requirements as indicated on the Santander Scholarship Platform.
6. Applications will be broken down into 2 phases:
 - Applications for phase 1 will take place from 9am on 01/02/2022 until 11pm on 31/03/2022. 150 applicants (25 per country) who meet the eligibility criteria will be selected at random to proceed to phase 2.
 - Applications for phase 2 will take place from 06/04/2022 until 11pm on 14/04/2022.
7. The 60 successful students (identified during phase 2) will be chosen by King's College London. This will take place after King's College London has assessed all applications as part of phase 2, including a review of the following information:
 - a. Proof of English Language Proficiency to at least C1 level in the Common European Framework of Reference for Language (CEFR) or equivalent*
 - b. Proof of academic grades to be working towards at least a 2:1 or equivalent **
 - c. Personal statement outlining their reasons for applying to the Programme
8. The 60 successful students will receive a confirmation email (informing them that they won) via the Santander Scholarship Platform. Upon receiving this, the winners must confirm their acceptance of the Grant ("place on the Programme") by clicking on the link in the email. Confirmation/acceptance of the Grant must be provided by 5pm on 16/05/2022 through the Santander Scholarship Platform. If, after 2 email attempts with at least 24 hours separation between them and a phone call if a valid phone number is available for the winner, the Grantor decides that it is not possible to get in touch with the winner, a new winner will be selected by King's College London from the original 150 applicants that made it through to phase 2.

9. Once the successful participants have accepted the Grant, they will receive an email (in due course) directly from King's College London with a link to complete their enrolment on King's Apply, King's College London's application platform.
10. The winners' details will be shared with the Santander Universities team based in their own country, for the purpose of arranging travel, and accommodation and payment of subsistence. The winner's details may also be used to invite them to provide a testimonial, or to participate in a case study.
11. The winners' surname and county will be available on request after 16/05/2022 for 30 days. The winners' information and winning entries (if applicable) must be provided to the Advertising Standards Authority on request in the event of a dispute. General terms

1. The Grantor reserves the right to withdraw any application to the Programme that is found to be in breach of any of the pre-established conditions and / or rules laid out in the Term and Conditions.
2. The Grantor reserves the right to update or amend these Terms and Conditions or foreclose the Programme without prior notice at any time.
3. The Grantor reserves the right in its sole discretion to disqualify any individual that corrupts or affects the administration, security, fairness, integrity or proper conduct of this Programme.
4. The Programme and these Terms and Conditions are governed by English law and any disputes will be subject to the exclusive jurisdiction of the courts of England.
5. To the fullest extent permitted by law and excluding death or permanent injury caused as a result of the Grantor's negligence, the Grantor accepts no liability for loss or injury as a result of the Programme or receipt or misuse of any prize fund.
6. No cash or other alternatives to the Grant will be offered and the Grant is not transferable.
7. The Grantor accepts no responsibility for applications lost, damaged or delayed in transit.
8. The decision of the Grantor is final, and no other correspondence will be entered into.
9. The Grant will be provided by the Grantor.

Data protection

When applying for the programme, applicants will be asked to provide their personal details (such as country of residence, university, full name including title, email address, date of birth, type and identification number of the country of residence or passport, gender, telephone number, nationality, education/qualifications including start and end date, area of expertise, professional experience and company sector, employment status, degree subject, proof of English Language Proficiency and proof of academic grades) which will be shared with Santander UK plc, King's College London and the students' respective universities (in respect of UK applicants only) for the purpose of managing this programme and allocating places on the Programme, as stated in these Terms and Conditions. Applicants will be advised when some information requested is optional and will be asked to provide consent to sharing certain personal information with partner universities and partner businesses. The winners' information will also be shared with the Santander Universities team based in their own country, for the purpose of arranging travel, and accommodation and payment of subsistence. The transfer of winners' information for this purpose is necessary for the performance of the contract with those winners. The winner's details may also be used by the local Santander Universities teams to invite them to provide a testimonial, or to participate in a case study. Where that team is based in a country which is deemed not to have adequate levels of protection for personal data, we will ask for consent to transfer the winners' information for this purpose.
