

General Terms and Conditions
“Santander IE Tech4Law Scholarships” Programme
2019/2020 Edition

I. Objectives

The “**Santander IE Tech4Law Scholarships**” Programme (“the Programme”) will assist students in their final year of a law Degree, or students who have graduated in Law during the four years prior to the Programme’s publication date from a university in Argentina, Brazil, Chile, Mexico, Poland, Portugal, Spain, the US or the UK, in gaining access to the training course forming the subject of the Programme during the 2020 academic year.

The aim of the **Programme** is to promote the development of digital and technological skills among the lawyers of the future and equip them with the basic tools required to understand the challenges and driving forces behind legal innovation in a digital world.

II. Recipients

This Programme will be open to students in their final year of a law Degree or students who have graduated in Law during the four years prior to the Programme’s publication date from a university in Argentina, Brazil, Chile, Mexico, Poland, Portugal, Spain, the US or the UK and who also meet the selection criteria set out below.

Obtaining a free place on the training course that is offered under the Programme will be compatible with holding other classroom attendance scholarships of a different kind that may be available to the student engaging in work experience under the Programme, regardless of whether these are public or private in nature.

III. Nature of the course

This Programme will form part of the High-Impact Online Programme (HIOP) Legal Tech online training course and 100 places will be made available.

The course, which will last for 5 weeks, will be given by IE Exponential Learning (“IE XL”) with academic supervision from IE Law School (“IE LS”) and it will be offered entirely in English.

During the course, participants will develop their knowledge and experience of how the various technologies offer competitive advantages and new business models in the legal sector, and they will acquire a series of skills and tools that can be used to understand the challenges and driving forces behind legal innovation in a digital world.

IV. Selection criteria:

Phase one:

- i. If the student is currently in their final degree course year, assessments will be based on their average mark for all previous years. If the student has already graduated from a

university or study centre in one of the countries listed in Clause One, the final average from their Law Degree will be taken.

- ii. A high level of English is required.
- iii. Candidates will complete an application form and take a short test.
- iv. Participating students must provide IE Foundation with a certificate of tax residence and they will be bound by the tax status that applies to courses subject to these General Terms and Conditions.

The first phase is open for registration until Monday, 15 June 2020, at 23:59 GMT+2 (Madrid time zone). The results will be published on Monday, 22 June 2020.

Phase two:

The 500 highest rated profiles based on the foregoing criteria (i), (ii) and (iii) will move on to the second and final phase of the selection process, replying to the question “Which circumstances, if any, might currently justify the use of facial recognition for remote biometric identification?” (a) in a one-minute video, or (b) in a text of no more than 600 words.

In order for places on the course to be allocated to participants, a Selection Committee comprising 2 representatives from IE Foundation, 2 representatives from Banco Santander, S.A.’s Universities division and 1 representative from IE Law School will confirm compliance with the selection criteria that are to be met by students, depending on the course being taken. The Committee may also assess any other selection criteria that it deems appropriate in the event that demand for places from students exceeds the number available.

With a view to ensuring that the Programme will benefit from the greatest possible number of students, if the Working and Monitoring Group comprising an equal number of representatives from both IE Foundation and Banco Santander, S.A. believes at any time that the planned number of places is not going to be filled, it may decide to apply other criteria for obtaining a place on the Programme, and it may even extend the deadline by which students may apply.

The 100 candidates who successfully complete this second phase will receive the scholarship and gain access to the course.

With the aim of enhancing the employability of university students, the **250 finalists of the Santander IE Tech4Law** program who finally do not get a place, will be able to access a MOOC training program on 'Intelligence Tools for Digital Age' of IE University on the platform Coursera. Both institutions will finance the certificate of said course that will allow them to make their profiles and abilities stand out in future selection processes. This course will only be offered in English.

The 10 highest performing students in the HIOP Legal Tech online course will have access to Banco Santander, S.A.’s Human Resources selection process in order to apply for an internship or full employment contract with the organisation.

Within the framework of the Programme, IE Foundation and IE Law School will offer 1 scholarship that will cover 100% of the matriculation fee for the Master in Legal Tech. During the final stage of the course, any students wishing to enrol for IE’s Master in Legal Tech may

apply to receive this scholarship. Their candidacy will be assessed on the basis of their academic results during the HIOP Tech4Law Online Course and the degree to which they meet both the requirements for admission to this Master's programme and the Committee's criteria for IE Foundation scholarships: excellence, financial need, diversity and contribution to the programme. All other costs connected with the Master's programme will be paid by the student receiving the scholarship.

The second phase will be open for registration on 22 June and will close on 6 July at 23:59 GMT+2 (Madrid time zone). The results will be published on Tuesday, 14 July 2020.

V. Management

Registration via the website created to this end at www.becas-santander.com is an essential requirement for anyone wishing to obtain a place, and the allocation of places will be notified using the management system provided.

VI. Allocation of places among candidates

Places will be allocated to students by IE Foundation up to 22 June 2020, and it will not be possible to extend this deadline under any circumstances unless otherwise decided by the Working and Monitoring Group. Students who are notified that they have been allocated a place will have 6 calendar days to indicate their acceptance via the website www.becas-santander.com.

Once the people selected to receive scholarships have been announced, IE XL will hold a week 0 in which those selected must show their commitment to the programme. Any selected candidate who does not actively participate and show their commitment during this first week prior to the beginning of the course will lose their scholarship and it will be allocated to another candidate who has met the necessary requirements.

In the event that, once the deadline has expired, some of the places allocated have not been accepted by students, the Working and Monitoring Group will allocate these places under identical conditions to other students who meet the necessary requirements.

Furthermore, in the event that demand for places from students exceeds the number available, the Selection Committee may examine any other selection criteria that it considers appropriate.

VII. Data protection

2. Purpose of processing and authority to process Programme data

Assignment of data to IE Foundation to support participants in the Programme:

Universaria will forward the personal data of those candidates who have given their express consent to IE Foundation, so that it may send out communications of an academic nature relating to its own programmes or the programmes of its collaborating partners via any medium, including electronically.

The authority that allows data to be processed results from the consent that is given expressly by the candidate by ticking the relevant box. In the event that a candidate does not tick the box and therefore does not agree to receive communications, or if a candidate who initially gave his/her consent withdraws it in the future, they may continue to enjoy the other services offered by Universaria, particularly this Programme.

3. Period during which data will be retained

The personal data provided will be retained for the amount of time that the contractual relationship continues, provided that its elimination is not requested by the candidate, unless it is required to be retained because it is necessary in order to comply with a legal obligation or required for the preparation, exercise or defence of claims.

If the data subject withdraws his/her consent or exercises his/her right of elimination, their personal data will be retained encrypted for the periods set out in law, for the purposes of responding to any liability originating from their processing.

4. Recipients of data

5. Rights of data subjects
